

**TERMS AND CONDITIONS FOR USE OF UK METROLOGY BOARD LTD
TRADEMARK AND UKAS NATIONAL ACCREDITATION SYMBOL**

1. GENERAL

1.1 The clients Quality Management System (QMS) is certified and therefore the UKMB trademark and UKAS symbol cannot be used in a manner that shows the relevant weighing or measuring instrument is certified.

1.2 The appropriate national accreditation symbol may only be used by the client of UKMB in connection with the certification body's award of UKAS accredited certification. The national accreditation symbol must be relevant to the certificate. e.g.

1.3 Holders of certificates issued by UKMB may use the appropriate national accreditation symbol in accordance with the requirements of these T&C's on stationery and publicity material or other items relevant to their certification. The national accreditation symbol shall always be used in conjunction with the trademark of UKMB (see Figure 1 below). Holders of accredited certificates may use the trademark of UKMB without the accreditation symbol.

Figure 1. Use of national accreditation symbol by holders of accredited certificates. The national accreditation symbol used must be relevant to the certification. The UKMB trademark shall be enlarged or reduced to fit into the space indicated. The UKMB accreditation number from UKAS shall be included (as indicated by (0000)). The Approved Body Number shall be included underneath the UKMB logo (as indicated by (000000)). The national accreditation symbol and the UKMB trademark shall be enclosed in a box (as indicated).

1.4 The Client may promote its certification in accordance with the terms set out in the Regulations governing the use of the certification marks. The UKMB trademark and UKAS symbol can be used by UKMB clients in accordance with appendix B of OPS&S Guidance, "The National Accreditation Logo and Symbols: Conditions for use by UKAS and UKAS accredited organisations (September 2021) " as relevant to management systems certification.

1.5 UK Metrology Board Ltd (UKMB) shall ensure that they audit the use of national accreditation symbols by their certificate holders. If the Client is found to be in breach of clauses 1.1 to 1.4 then UK Metrology Board Ltd (UKMB) reserves the right to suspend or withdraw any certificates issued.

2. DEFINITIONS

"UKMB Trademark" means the UK Metrology Board Ltd trademark registered with Intellectual Property Office (IPO) ; Trademark No. UK00003775114.

"UKMB Certification Mark" means UK Metrology Board Ltd trademark.

"Codes of Practice" means those codes of practice &/or terms and conditions issued by UKMB in accordance with the relevant certification scheme.

"UKMB Certification Mark Terms and Conditions" means the terms and conditions of use of the UK Metrology Board Ltd trademark and terms and conditions for certification services.
